Agenda No 6: Social Security Schemes

Agenda 6A: Term Insurance for Samaj Members (Age Group 55 - 60) for next three Years

It is proposed that needy persons whose Gross annual income in the family is less than INR 500,000/- (Rupees Five lakhs only) to be provided a term Insurance plan of Rs.500,000/- (without any Tax deductions) on first come first serve basis to the Head of Family/Any family member for consecutive 3 Years commencing from Jan 2022. 100% premium to be reimbursed by Samaj Trust on submission of the receipts by the member. It is mandatory that the Head of Family or any other earning Member must be Paid Life Member of Shri Dasa Porwad Vaishnav Samaj (Nandurbar) Mumbai to avail the said benefit and provide an undertaking to Samaj that their annual income of the family is less than 5 Lakhs per annum. Details of the scheme attached as Annexure IV.

For the above scheme, an annual budget of Rs.2 Lakhs is proposed for the current year and Rs. 2 lakhs for each year for consecutive 2 years.

Agenda 6B: Securities for Widows-Widowers

It is proposed to provide financial support to the more challenged Widows-Widowers of Samaj commencing this financial year 2021- 2022. Only Widows-Widowers who have no regular Income for their livelihood would be considered under this scheme. The Financial support will be extended only on basis of the Application received from the concerned Widow or from any one of her Family Member or his / her well - wisher from Samaj. Once approved in the AGM, the Applications will be requested to be received by the Trust during the period 1st Oct 2021 till 30th Oct 2021 and can be extended further.

For the above scheme, an annual budget of Rs.2 Lakhs is proposed for the current year and Rs. 2 lakhs for each year for consecutive 2 years.

Members who are eligible for the said scheme are requested to submit the application form as per prescribed format and along with the Payment receipt in original to the following address:

On receipt of the application and the same is found in order, the Trust will arrange to remit the Insurance premium amount to the concerned Member through crossed cheque or transfer through NEFT to the members bank account directly. The application form can be downloaded from our website directly.

All Benefits / Schemes offered by Samaj Trust are in Good Faith and for overall welfare of Samaj Members.

Members were requested to provide suggestions and/or raise any queries.

Query: Mr Jignesh Shirishchandra Shah sought clarification that If a Widow is not a Paid Member and she needs help, can she avail the benefits of the said scheme:

Reply: In case some Member of Samaj seeks benefits under any of Trust Schemes and he/she is not the Paid Life Member of Shri Dasa Porwad Vaishnav Samaj(Nandurbar) Mumbai, then the concerned member has to become first the Paid Life Member by filling Life Membership Form and , making necessary payment & then he/she becomes eligible to receive these benefits.

Dhavalbhai also added that such Paid Life Members will also become eligible for other schemes as and when they are introduced. .

Mrs Hemali Vikram Gujrati too stated she supported the Term Insurance Scheme for Samaj Members

As there were no other query on the schemes the Resolution was passed as under:

Resolution to Agenda no. 6A & 6B:

Resolved that the MC is authorized to implement Term Insurance scheme for 50 Samaj Members at budgeted cost of Rs 200,000/PA (Rupees Two Lakhs only). and also authorized to implement "Securities for Samaj Widows- Widowers "with Budgeted cost of Rs 200,000 /PA for Three Financial years commencing from Jan 2022 against Application from close Family Member or from the Wellwisher of concerned Widow- Widower In the event of demise of Beneficiary the financial assistance will be discontinued and Trust will not have any liability towards the Departed Widow-Widower.

Further if required, MC is authorized to make necessary changes for ease of implementation, if required.

Agenda no.7 - Point Related to proposed Revision in Fees of Samaj Paid Life Membership:

The information as listed below was shared with the Members with respect to existing Memorandum of Association (MoA) of Shri Dasa Porwad Vaishnav Samaj (Nandurbar) Mumbai,

- 7.1: All are Members of "Shri Dasa Porwad Vaishnav Samaj (Nandurbar) Mumbai by Birth and have family roots from Dasa Porwad in Nandurbar thru Parents Dada/ Dadi Nana/ Nani
- 7.2 Out of above Members, many have opted to be Samaj Paid Life Member by paying Life Membership Fees prevailing at that point of Time. As per Data as on Date " Shri Dasa Porwad Vaishnav Samaj (Nandurbar) Mumbai" have more than 425 Members. The List of such Members

was posted on What's Groups from 1st Feb 2021 to 27th Feb 2021. This will be updated around Nov-Dec 2021.

- 7.3 Donor Members List is almost ready for period from 2014 to Sept 2021. This updated List will be posted on Samaj What's Up Groups in and around Nov-Dec 2021.
- 7.4 As on date Samaj Paid Life Membership is given to Members within above understanding at Rs 1000/ per Member with Voluntary Contribution of Rs 1500/ per family towards Samaj Seva Fund. These funds were used to help Samaj Members affected due to Covid-19, major surgery etc.
- 7.5 Now MC Members propose that the collection of Samaj Seva Fund be stopped. And the earlier Life Membership per Member to be revised to Rs 1500/ from earlier Rs 1000/ from immediate effect
- 7.6 Complete Rational was also explained.

As there were no questions, it was proposed to raise the Life Membership from Rs. 1000/- to Rs.1500/- and discontinue Samaj Seva Fund collection of Rs.1500/- with immediate effect.

Resolved that with immediate effect the Paid Life Membership Fee is increased be revised to Rs Rs 1500 per Member and Samaj Seva Fund Collection to be discontinued.
